

2018 Delaware County 4-H Terminology

Advisors-Trained adult volunteers that lead 4-H clubs and assist members with projects and prepare youth for judging. Questions should be directed to advisors first and if they are unable to answer them should then be referred to committee members assigned to that specific project and/or the Extension Office. See committee members for a list of names and contact information.

Animal ID- Is a form filled out by exhibitors taking **Beef and Dairy Feeders, Hogs, Horses, Alpacas and Llamas** to identify their fair animal via a photograph attached to the animal ID form. See animal exhibitor packets for more details.

Camp-This overnight camp is Friday, July 13 to Tuesday, July 17 at 4-H Camp Ohio. 4-H members and non-members age 8 (and just finishing 3rd grade) to age 13 can attend Junior Camp. Youth age 13 to 16 can attend Teen Camp. Thirteen-year-olds (as of 7/13/2018) can decide which camp they will attend. The camps will be held at the same time on the same facility, but will offer separate schedules and activities.

Camp Counselor- Are 4-H teens that are at least 16 by the first day of camp and have met all the training requirements to be a counselor. Applications are due the first week of January each year.

Camp Scholarships- Delaware County 4-H members can apply for a camp scholarship due Monday, June 4th.

C.I.T.- Counselors in Training are 4-H teens that are at least 15 years of age and have met all the training requirements to be a C.I.T. at camp. Applications are due the first week of January each year.

Cloverbud Camp- Cloverbud camp is open only to Delaware County 4-H Cloverbuds. Cloverbud camp is scheduled for Saturday, June 30 at the Delaware County Fairgrounds from 9:00AM to 3:30PM. Pre-registration is required to participate and is due June 6th.

County Achievement Awards- Members apply in October to be recognized for county achievements at the 4-H banquet in November.

Committee members- Trained adult volunteers that serve on a specific project committee and help organize events for that specific species or project type. Specific questions pertaining to a project should refer to the head committee member listed below.

Exhibitor Handbook (Fair Book)- This handbook published each summer by the Delaware County Fair and details all project rules, guidelines and event times for projects exhibited at the fair. Refer to this handbook for project requirements, restrictions and exhibitor guidelines. Available from club advisors and the Extension Office.

Enrollment Permission Form- All members exhibiting Dogs or Horses must complete a permission form annually.

Fair Eligible- To be Fair Eligible members must enroll by the county deadline, be in good standing with their club, complete a fair entry for each project going to be exhibited, complete any and all tagging, tattooing and animal ID requirements, and attended any mandatory trainings for those projects such as Quality Assurance.

Fair Entry- All youth who wish to exhibit at the fair must complete an online entry through FairEntry. Online instructions are available through delaware.osu.edu . This is **not** the same as your 4-H online project registration! Fair entries can be completed at <http://Delawarecojrfair.fairentry.com> due (8/24/18 @ 11:59 PM through the online system). This is a Hard Deadline!

Fair Judging & Project interview- This is an opportunity for youth to share their project achievements with a judge experienced in that project field. This is mandatory to exhibit and receive premiums at the Delaware county Fair. This is a one-on-one interview where the judge will ask questions about the project and 4-H experience. The judge will award a grade of A, B, or C. Premium levels are determined by the grade. Please let the Extension office know ahead of time if your youth needs any special accommodations.

Fair Awards (Delaware County Fair Awards) - Awards, such as plaques and rosettes given based on judging of projects specific for Delaware County Fair. Delaware county fair award judging events are:

*Other make-up judging events are offered, however the exhibitors are not eligible for Delaware County Fair awards, only grade and premium.

Junior Fair Board- This yearly opportunity is available to 8th grade and older 4-H and FFA members. They assist at project judging and fair activities. Applications are due the first week in January.

Newsletter- An update sent to advisors in the winter, summer, August and fall highlighting events and program changes.

Project Exhibit Requirements- Are outlined in the Exhibitor handbook.

Quality Assurance (QA) - Is a **required** training program for 4-H youth taking livestock projects including: **Market Beef, Dairy Feeders, Market Hog, Market Lamb, Market Goat, Market Turkey, Market Poultry, Market Duck, Market Rabbits, Lactating Dairy Cows and All Goats (pygmy, pack, dairy, and meat breeding)**. This program teaches 4-H youth how to use best practices that guarantee producing quality and safe animal products for consumers, as well as responsible animal handling, care and welfare in not only farm animal production, but also with companion and performance animals. * The QA clinic on June 2 is after the deadline for the Hartford Fair and will not meet the requirement for exhibitors.

Summer Judging- This is the primary judging for all Food, Clothing, and members interested in becoming State Fair Representatives. 4-H members who would like to be considered for any Delaware County Food or Clothing awards must attend summer judging. All other still projects that would like to be considered for State Fair Judging may attend summer judging. Food projects will be judged at the **Food Fair (7/20/18)** location & time TBA), **Clothing Projects** will be judged (7/19/18 location & time TBA) and State Fair Selections for: **Related Home Economics, Photography, Woodworking, Electricity, Conservation, Welding, Leadership and Self-Determined** will take place (7/19/18 location & time TBA).

Style Review and State Fair Delegates Award Program- The style review is an opportunity for individuals taking a sewing project to model their item(s). Any clothing project that wants to be eligible to win an award must be present at the style review to receive their award. Following the style review is an awards program for all projects that completed summer judging to announce State Fair Representatives for each eligible project. The style review and awards program will take place (7/19/18 at 7PM, Location TBA). Food projects will be recognized on 7-23-18 at 7PM at the Extension office.

Tagging- This is the required ear tag identification process for the following fair livestock species: **Market Beef, Dairy Steers, Feeder Calves, Market Lambs and Market Goats**. Tag in dates for 2018 are as follows: Market Beef and Dairy Steers (3/5/18 @ 8-9 AM), Beef and Dairy Feeder Calves (8/18/18 @ 8-9AM), Market Lambs (6/2/18 @ 8-10AM) and Market Goats (6/2/18 @ 9-10AM). All Tagging takes place at the Delaware County Fair Grounds.

Tattooing- All Rabbits (except pet rabbits) must be tattooed before fair. Please contact Rabbit committee member if assistance is required. Rabbits may be tattooed during Rabbit project book judging (9/8/18 from 9:30 AM- 1:30 PM) at the Delaware County Fair Grounds.

4-H Volunteers- These are club advisors and fair committee members that help organize meetings, clinics and other opportunities for youth.
