We have a few more Delaware County Fair reminders for you. More specific information for Beef, Poultry, Pigs, and Goats will be coming out very soon.

1. Sale pictures are due 9-7-24 for Market Exhibitors
 - a. Market project exhibitors are required to take a picture with their project animal for use by the sale committee. Exhibitors must submit pictures by 11:59PM Sept 7th - form found at https://linktr.ee/delawareco_jrfairsale
 - b. Please name the file to the exhibitor's name before uploading. **Example: "Jane_Doe_2024_Turkey"** - Please do not write the exhibitor's name ON the photo.
 - c. Exhibitors must be in proper show attire for the picture. Dress code is rule #9 of the sale rules on page 114 in the Exhibitor Handbook. <https://d16tk4f786nwik.cloudfront.net/wp-content/uploads/2024/06/26.-Jr-Fair-Sale.pdf>
 - d. The Extension Office is unable to check on the status of sale pictures. Email mpharazyn1@gmail.com for questions- use Jr. Fair Sale photo question as the subject line.
2. W-9 for Market Exhibitors
 - a. W-9 forms must be submitted to Sr. Fair Office located on the fairgrounds.
 - b. Forms will be available at judging on September 7 to fill out and collect

3. DRUG USE NOTIFICATION FORMS (DUNFs)- Due by 9-14-24
 - a. **Market Beef, Beef Feeders, Dairy Feeders, Market Goats, Lactating Dairy Goats, Market Lambs, Market Hogs, Market Chickens, Market Turkeys, Market Ducks, Market Rabbits, and lactating Dairy Cattle** must complete a DUNF before exhibiting at the fair.
 - b. Drug Use notification forms will be online again this year at: <https://go.osu.edu/deldunf>.
 - c. Only put medication on the form **IF** the withdraw time has not completed by 9-13-24.
 - d. One form is required per animal (Market chickens and Market rabbits are one per pen).
 - i. Please use a tag number (not a name) for your animal's identification number.
 - ii. **Market Hogs must use their fair tag- must fill out post weigh-in**
 - iii. **Market Poultry must use leg band/ wing band as ID**
 - iv. **Market Rabbits must use Tattoo as ID**
 - e. Please fill this out between **September 2 and September 14**.
 - f. If you give medication to your animal after submitting your DUNF, fill out the form again.
4. Skillathon reminder 9-7-24 from 11-2
 - a. You can still come and participate in skillathon even if you did not enter it.

6. Showmanship Rule update/Clarification-
 - a. The showmanship rules this year have changed from last year. They are also slightly different than what has been communicated previously. The rules/ show procedures that will be enforced are the ones that are printed in the Exhibitors handbook on page 148.
 - i. Showmanship winners from a previous year Will be allowed to enter the ring for department showman of showman class.
 - ii. Members no longer "bump" age divisions if they won last year. Members will always show in their 4-H age division unless they are last year's department showman of showman winner. In that case, they are only eligible to enter the ring for that department showman of showman class.
